### **Proof that caring works**

Roughly 5,000 people are homeless on any given night in metro Atlanta. At CaringWorks, we demonstrate that men, women, and children can escape homelessness and lead healthy, productive lives. Through quality short-term and long-term housing, behavioral health, and a myriad of support services, we help nearly 1,000 people a year break the cycle of homelessness and maintain stable housing.




100% of clients who are accepted into our permanent supportive housing programs have experienced chronic homelessness and have at least one disabling condition.



#### Increasing Access to Behavioral Health

In addition to working with partners to help many of our clients access behavioral health services, **more than 230** of our clients received these services directly from CaringWorks either in our outpatient behavioral health facility, in their homes, or via telehealth.

Mental and behavioral health services are one of the most significant health needs in Georgia, according to the 2022 Georgia Community Health Needs Assessment. To help address this need in one of the most underserved areas of the state, CaringWorks opened an office in College Park to expand access to mental health services for residents of Southside Atlanta and surrounding communities.
