## Limited Use Agreement & Photo/Video Release

By submitting an entry to the Richard Mackelfresh All Star Jam to End Homelessness Creative Artist Challenge (the “Challenge”), you (“Entrant”) agree to the following terms:

### 1. Ownership of Work

Entrant affirms that they are the sole owner of the work submitted (lyrics, music, poem, spoken word, or performance video). Entrant retains all rights, title, and ownership of their submitted work.

### 2. Limited License Granted

Entrant grants to CaringWorks and the All Star Jam (collectively, “Organizers”) a non-exclusive, royalty-free, worldwide license to use submitted works, including:

- The original submission (video/audio/text), in whole or in part;
- Clips from finalist performances recorded live at the All Star Jam event;
- Such materials may be used for:
  - Promoting the All Star Jam in future years;
  - Showcasing impact in reports to CaringWorks funders;
  - Inclusion on the CaringWorks or All Star Jam websites, social media, or other promotional outlets;
  - Use at events to promote awareness or raise funds to end homelessness.

### 3. No Further Compensation

Entrant understands no additional fees, royalties, or compensation will be provided for this use beyond any awards/prizes, if any, officially granted through the Challenge.

All prizes and awards will be decided and distributed at the sole discretion of the All Star Jam team. The Organizers reserve the right to withhold or modify prizes if entries do not meet the standards, themes, or requirements of the Challenge.

#### 4. Release of Liability

Entrant acknowledges that once material is shared online or via social media, Organizers cannot control third-party sharing or use. Entrant releases and holds harmless CaringWorks, the All Star Jam, their affiliates, officers, directors, sponsors, and partners from any claims or liability arising from third-party use of Entrant's work once published online.

#### 5. Personal Image & Performance Release

Entrant grants permission to be photographed, filmed, or otherwise recorded during the Challenge and any live performances. Entrant authorizes Organizers to use such recordings, in whole or in part, in promotional, fundraising, and reporting materials consistent with Section 2.

#### 6. Warranty & Indemnity

Entrant warrants that their work does not infringe on any copyright, trademark, or other rights of third parties, and indemnifies Organizers against any claims related to infringement or unauthorized content. Entrant also confirms all individuals appearing in the submission have granted their consent for participation.
